LOCKHEED CONTRACT—INQUIRY WHETHER MINISTER OF NATIONAL DEFENCE ADVISED TREASURY BOARD OF FINANCING ARRANGEMENTS

Mr. Allan B. McKinnon (Victoria): The minister still has not told me whether the Minister of National Defence ever advised him of this bridging arrangement with Lockheed. Three hundred million dollars is an amount of money that would, with few exceptions, be beyond the capability of almost any corporation to raise, or to establish a line of credit for. Are we to believe that the Minister of National Defence was able to get by the Treasury Board without the President of the Treasury Board asking for details as to the source of such funds? The decision made was important enough to cost the taxpayers \$16 million.

Hon. Jean Chrétien (President of the Treasury Board): Mr. Speaker, the question about the \$16 million is entirely beside the point. We knew, at Treasury Board, that Orion would probably cost us more than anticipated, that there would eventually be interest of over \$100 million to be paid. At a subsequent meeting held sometime last December, Treasury Board gave its approval.
