Ninety-nine such letters were sent and the Secretary of State for External Affairs has personally repaid the government for the stationery, envelopes, and postage.

Ouestion No. 1,691-Mr. Cossitt:

Did the Secretary of State for External Affairs write a letter dated October 20, 1980, to what he referred to therein as "Special Friends" advising them in part "the government... has eased the requirements for claimants of Unemployment Insurance benefits in the auto industry, a condition which applies only to Windsor" and, if so (a) what is this special treatment being received by Windsor (b) is similar treatment being received in regard to UIC by other municipalities where automobiles are being produced such as Oakville and Oshawa and, if not, for what reason?
