Bob Kaplan (Solicitor General):** In so far as the Correctional Service of Canada is concerned: Robson Centre, Pandora Centre, Elbow Lake Forestry Camp, Ferndale Institution, Matsqui Trailer Unit, Mission Institution, William Head Institution, Mountain Institution, Matsqui Institution, Kent Institution.

(a) and (b) There were no psychiatrists at the above-mentioned institutions. Psychiatric services were provided at the Pacific Regional Psychiatric Centre (RPC).

If hospitalization was required, it would take place in the institutional health care centre, a provincial mental health facility or the Ontario Regional Psychiatric Centre, depending upon the severity of the illness.
