#### CREDIT SCREENING SYSTEM INTRODUCED BY BELL CANADA

**Mrs. Margaret Mitchell (Vancouver East):** Madam Speaker, I rise on a matter of urgent concern to low income people. Bell Telephone Company has instituted a major attack on the poor through the introduction of a credit screening system which invades privacy and will deprive many pensioners, single parents, the disabled and the unemployed, of telephone services. Therefore I move, seconded by the Hon. Member for Mission-Port Moody (Mr. Rose):

That the Government, through the CRTC, require Ma Bell to withdraw this discriminatory screening policy, which is a dangerous national precedent, and eliminate advance payments without due cause.
