## UNITED STATES STRATEGIC DEFENCE INITIATIVE

**Mr. Mike Cassidy (Ottawa Centre):** Mr. Speaker, my question is directed to the Minister of State for Science and Technology. It follows up on the question asked by my Leader with respect to possible instructions to the National Research Council for participation in the American star wars project.

The letter which my Leader referred to indicates that the NRC has been instructed to find \$6 million for the purpose of star wars research, despite the very sharp cuts imposed on the NRC last fall. Will the Minister inform the House whether such instructions have been given to the NRC, or has it been told to set aside \$6 million, or some other amount, for star wars, in the event that the Government's decision is positive?

**Hon. Thomas Siddon (Minister of State for Science and Technology):** Mr. Speaker, the Hon. Member and his Leader are on little more than a fishing trip. In fact the NRC is hard enough pressed to find funds for its existing programs.

**Some Hon. Members:** Hear, hear!

**Mr. Axworthy:** That's right.

**Mr. Siddon:** The question is totally hypothetical and based on fiction rather than fact.

**Mr. Cassidy:** Mr. Speaker, the Minister neglected to say that it is the cuts imposed by his Government which have backed the NRC into that kind of a corner.
