When they signed an agreement in 1979, they simply transferred \$500 million to the provinces, to Progressive Conservatives and separatists, in exchange for the \$35 million we had left to develop the Olympic Games, amateur sport and medical research! That is what they did!

CORPORATION'S ISSUANCE OF ADVERTISING CONTRACTS

Mr. John Bosley (Don Valley West): Mr. Speaker, my question is for the same Minister. I put the question on Friday last, and the President of the Treasury Board took it as notice for the Minister.

The Canada Sports Pool Corporation has awarded two advertising contracts, one of them to Planicom in Montreal, specifically to the publicity manager for John Turner. Were those contracts tendered, Mr. Speaker? If so, was the French language contract awarded to the lowest bidder? Will the Minister table those tenders? If they were not tendered, why not?

Hon. Jacques Olivier (Minister of State (Fitness and Amateur Sport)): Mr. Speaker, I simply want to say that the two advertising agencies were selected by the Canada Sports Pool Corporation. Now, some Members seem to want politics to be constantly involved in the corporation's decision-making process. That decision was made entirely by the Canada Sports Pool Corporation and not by the Minister.

IMPACT OF EVENTUAL FISCAL TRANSFERS
