Mr. Chrétien: I would like to ask the Deputy Prime Minister if he read that document, and if we can take it as the sum of the brains and talents of the Government when it tells us that we will have a committee and at the same time the Government intends to make decisions on a daily basis, making a farce of participation by the Canadian public?

Mr. Chrétien: I am very sorry. I have known the Hon. Minister since 1963, and his admission that he read it and found it very good means he has gone down in my esteem very rapidly.

They howl about having the Standing Committee on External Affairs and National Defence obtain a reference about NORAD, but my colleague, the Government House Leader, has made offer after offer to those opposite to bring a NORAD reference before the committee so it can be discussed, and they refuse to have that discussion.
