basic legislation of 1961. It is that I hope those charged with implementing the legislation, those actually dealing with the administration and those who will be studying the results, between now and the time these present arrangements run out in 1967, whether they be provincial or federal authorities, will study the problem with wisdom and without emotion. I hope they will study it with judgment, without prejudice and without arrogance, and that this wisdom and this judgment in that connotation, between now and the time when these agreements or this legislation will have to be reconsidered, will be such that having reached conclusions on this basis, we may be ready in 1967 for a solid approach to a reassessment of methods and possibly a basis that may rest on some stability and will permit a formula for dealing with the needs of the provinces without having to resort to a program of expediency. I regard the methods which we have, other than the principle of equalization, as being methods of expediency.

It may be that we will not find any other method in the interval, but I hope that a real effort will be made and that some way will be found, whether in the reallocation of certain powers and authority as between federal and provincial authority, whether in a reassessment of responsibility, or whether to a larger extent the provinces are to be left to tax in their own way and raise the moneys they need, and that the federal authority will tax for its own needs and for those items which in the interests of federation, should be the burden of the Canadian central authority.

Motion agreed to and bill read second time.
