

Canadian Battalion, 16th October, 1917. Promoted Lance-Corporal, March, 1916. Service and principal action: Amiens, 1918; trench warfare, 1917. Ill—pneumonia—July, 1916; gun shot wound in the right hand, 11th August, 1918. Demobilized, 6th June, 1919. Returned to duty with the Bank, 21st June, 1919.

WILSON, ARCHIE GORDON—Lieutenant. Born 10th May, 1893, at Barrington, Nova Scotia, Canada. Father, A. M. Wilson, Postmaster. Educated at Barrington High School. Entered the service of the Bank, 15th August, 1908. Enlisted, 26th November, 1917, from London, England, branch, in Royal Flying Corps, with the rank of Flight Cadet. Transferred to Royal Air Force, 1st April, 1918. Promoted Lieutenant, 27th September, 1918. Service: With No. 80 Squadron in France during October and November, 1918. Demobilized, 5th April, 1919. Returned to duty with the Bank, 6th May, 1919.

*WILSON, ANDREW MURDISON—Corporal. Born 15th August, 1897, at Musselburgh, Scotland. Father, Andrew Wilson, Registrar, Council of Higher Education, St. John's, Newfoundland. Educated at Presbyterian and Methodist Colleges, St. John's. Entered the service of the Bank, 4th February, 1916. Enlisted, May, 1916, from Springhill branch, in 193rd Battalion (Nova Scotia Highlanders), with the rank of Private. Transferred to 25th (Nova Scotia) Battalion, January, 1917. Promoted Corporal. Service and principal actions: Vimy Ridge, 1917; wounded about 7th May, 1917 (in the face, slight). Attended classes at the base from May to August, 1917. Rejoined 25th Battalion in August, 1917.

Killed in Action on his 20th birthday, 15th August, 1917.

WILSON, CHARLES WILLINGHAM—Private. Born 26th July, 1889, at Edinburgh, Scotland. Father, William John Wilson, Custom House Officer. Educated at Daniel Stewart's College, Edinburgh. Entered the service of the Bank, 15th March, 1910. Enlisted, 12th February, 1915, from East Vancouver branch, in 6th Duke of Connaught's Own Rifles, with the rank of Private. Transferred to 47th Canadian Battalion, 12th March, 1915; 30th Reserve Battalion, October, 1915; 3rd Canadian Machine Gun Corps, 9th March, 1916. Principal actions: Ypres, Somme, 1916; Vimy, 1917. Shrapnel wound in the right shoulder, 5th June, 1919. Machine-gun bullet wounds in both thighs (right leg amputated), 9th April, 1917. Demobilized, 30th September, 1918, on account of being physically unfit for further military service. Returned to duty with the Bank, 15th October, 1918.
