

Timothy Daly, Engineer, &c., on Parliament Hill, Ottawa, to be paid to such person or persons as the Minister of Public Works may determine, \$124 ; Gratuity to Frederick L. Eaton, furnace fitter, injured by explosion of hot water boiler at Springhill, Nova Scotia, Public Building, 5th October, 1903, \$1,000 ; Chief Architect's Office—Salaries of architects, draughtsmen and clerks, (notwithstanding anything in the Civil Service Act—Additional amount), \$10,000 ; Survey of head waters of the Ottawa River and tributaries with a view of devising a scheme for the regulation of the water levels of the upper reaches of these streams, so as to afford increased facilities for navigation purposes, the descent of timber, &c.—Additional (Revote, \$5,000), \$15,000, for the year ending 30th June, 1905.

94. Resolved, That a sum not exceeding Twenty-three thousand five hundred and fifty-seven dollars and twenty-nine cents be granted to His Majesty, for Slides and Booms—Ottawa District—Slides and booms, &c.—Repairs and supplies, \$20,000 ; Gatineau River—Compensation to Messieurs Gilmour & Hughson for the use of their retaining booms, &c., at the Cascades, during fiscal year ended 30th June, 1903—(Revote of lapsed amount), \$600 ; Gatineau River—To provide for recouping to Messieurs Gilmour & Hughson and the W. C. Edwards Co., (Limited,) amounts paid by them to Mr. Samuel Bingham to reimburse expenditure he incurred in 1900 and 1901, in placing booms in position, manning same, &c., \$2,957.29, for the year ending 30th June, 1905.

95. Resolved, That a sum not exceeding Nine hundred and twenty dollars be granted to His Majesty, for Library—To increase the salary of A. H. Todd, Chief Clerk, to \$2,200 from 1st July, 1904, (notwithstanding anything in the Civil Service Act), \$300 ; Further amount required for contingencies, \$620, for the year ending 30th June, 1905.

96. Resolved, That a sum not exceeding Twenty-three thousand dollars be granted to His Majesty, for Franchise Act, further amount required, \$20,000 ; Printing, binding and distributing the laws, \$3,000, for the year ending 30th June, 1905.

97. Resolved, That a sum not exceeding Five thousand dollars be granted to His Majesty, for Public buildings—Nova Scotia—Glace Bay—Public Building—Additional, for the year ending 30th June, 1905.

98. Resolved, That a sum not exceeding One hundred thousand dollars be granted to His Majesty, for Public Buildings—Ontario—Belleville—Armoury, \$20,000 ; Guelph—Armoury, \$20,000 ; Peterborough—Armoury, \$20,000 ; Stratford—Armoury, \$20,000 ; Woodstock—Armoury, \$20,000, for the year ending 30th June, 1905.

99. Resolved, That a sum not exceeding Five thousand dollars be granted to His Majesty, for Public Buildings—North-west Territories—Saskatoon—Public Building, for the year ending 30th June, 1905.

100. Resolved, That a sum not exceeding Thirty-three thousand seven hundred dollars be granted to His Majesty, for Harbours and Rivers—Nova Scotia—Victoria Beach—Further amount required, \$25,000 ; Harrigan's Cove—Wharf, \$1,200 ; West Chezzetcook—Improvements, \$3,500 ; East Chezzetcook—Breakwater, \$4,000, for the year ending 30th June, 1905.

101. Resolved, That a sum not exceeding Twenty-two thousand eight hundred dollars be granted to His Majesty, for Harbours and Rivers—New Brunswick—Mace's Bay—Wharf, \$3,500 ; Great Salmon River—Groyne and breakwater combined, \$4,300 ; Quaco Harbour—Eastern breakwater, \$15,000, for the year ending 30th June, 1905.

102. Resolved, That a sum not exceeding Two thousand dollars be granted to His Majesty, for Harbours and Rivers—Quebec—Chateauguay River—Enlargement at discharge into St. John River—(Revote), for the year ending 30th June, 1905.

103. Resolved, That a sum not exceeding Sixty-five thousand dollars be granted to His Majesty, for Harbours and Rivers—Ontario—Toronto Harbour—Extension to breakwater, \$40,000 ; Port Stanley—Harbour improvements, \$25,000, for the year ending 30th June, 1905.

104. Resolved. That a sum not exceeding Four thousand one hundred and fifty dollars be granted to His Majesty, for Civil Government—Departments generally—Contingencies—Additional sum required for care and cleaning departmental buildings, for the year ending 30th June, 1905.
