respect of new depreciable property will continue to be received under this program until December 31, 1963, when the program expires. Under the proposed measures of tax and depreciation benefits to new manufacturing and processing enterprises in designated areas, the Drumheller national employment service local office area has not met the criteria of unemployment and slow economic growth in order to qualify as a designated area.

REMOVAL OF STRONTIUM 90 FROM MILK

Question No. 1,439—Mr. Cameron (Nanaimo-Cowichan-The Islands):

In view of the four and five fold increase of strontium 90 in milk reported by the Department of National Health and Welfare, has the department any plans to inaugurate in conjunction with the provinces, a program to remove strontium 90 from milk by utilizing the method successfully employed elsewhere?

Miss LaMarsh: No. While there has been a substantial increase in the concentration of strontium 90 in milk, this was expected as a result of the extensive atmospheric weapons testing programs conducted in 1961 and 1962. It is also expected that peak levels have already or will occur very shortly and that thereafter the concentration will decrease substantially again. The department has constantly emphasized the importance, in assessing the significance to health, of comparing reference standards with averages for extended periods, such as a year, rather than with individual values. On this basis values reported to date are well within acceptable limits.
