statement on this matter. According to the latest reports available, an Israeli force including tanks and armoured vehicles crossed the hon gentleman's question as notice. the Jordanian border on Sunday morning and carried out an attack on a village south of Jerusalem. This attack was apparently carried out after three Israelis were killed and several injured as a result of the mining of a patrol vehicle near the Jordan border. According to the information so far in hand it would appear that the Israeli reprisal action was the largest we have seen in some years and resulted in loss of life and considerable damage to property. I understand that the United Nations observers in the area succeeded in negotiating a cease fire and investigations are now under way which will lead to a report to the Secretary General of the United Nations.

The Canadian government is seriously concerned over the acts of violence which have taken place in the area during recent months, and regrets that this violence is now taking on a more serious form. It is our sincere hope -a hope which I am sure is shared by all hon, members-that both sides will use due restraint in the situation which has arisen and that the cease fire negotiated by the United Nations observers in the area will be maintained.

Mr. Nesbitt: Is the Prime Minister in a position to let us know whether there have been any casualties in the Canadian forces serving with the United Nations?

Mr. Pearson: I do not have any detailed information about that point, but since the incident took place on the Jordanian border and since the Canadians are in and around the Gaza strip, I should think it highly unlikely.
