

*Public Service Employment Act***PUBLIC SERVICE EMPLOYMENT ACT**AMENDMENT RESPECTING DISPLAY OF POLITICAL  
SIGNS AT RESIDENCE

**Mr. John Burton (Regina East)** moved for leave to introduce Bill C-277, to amend the Public Service Employment Act (political partisanship).

**An hon. Member:** Explain.

**Mr. Burton:** Mr. Speaker, the Public Service Employment Act prohibits federal civil servants from taking part in most political activities. However, it is made clear that they have the right to attend political meetings, contribute funds to candidates or parties and apply for leave to run for nomination as a candidate. My bill would extend these rights to include the right to erect posters or signs at one's place of residence.

Motion agreed to, bill read the first time and ordered to be printed.

**Hon. Allan J. MacEachen (President of the Privy Council):** Mr. Speaker, I move:

That the sitting be suspended this day until the call of the Chair.

I have in mind that Royal Assent is possible later this day—
