QUESTIONNAIRE TO FARMERS ON FORM OF PAYMENT PREFERRED FOR WHEAT USED DOMESTICALLY

Mr. S. J. Korchinski (Mackenzie): Mr. Speaker, I have a question for the minister responsible for the Wheat Board. Did he personally authorize the questionnaire which went out to 180,000 farmers asking them about the method in which they wished to have payments made for wheat used domestically?

Hon. Otto E. Lang (Minister of Justice): Yes, Mr. Speaker.

**Mr. Korchinski:** May I then ask the minister why farmers are asked to finance a questionnaire intended to answer political questions which should be properly answered by the Liberal party?

Mr. Lang: Mr. Speaker, I should just like to make clear to the hon. member that the implication of his question, and that of another member the other day, that this is somehow being paid for by the farmers is quite wrong. It is part of the general government administrative costs. It has often been said in this House that it is important for us to consult with farmers and farm organizations on important matters. In this case there was a significant difference of view among farm organizations and I thought I should take this rather straightforward and simple question to the farmers directly. I am surprised that the hon. member is objecting to that.

Some hon. Members: Hear, hear!

Mr. Korchinski: I rise on a question of privilege, Mr. Speaker. It is simply that the minister in his capacity as the minister who answers in the House for the Canadian Wheat Board is exercising a privilege that is not afforded to members of other parties in the House and in doing so is using funds not properly funds of the government but funds of the farmers. This is money that has been accumulated—

Mr. Speaker: Order, please. I suggest to the honmember that this is hardly a question of privilege. It seems to me it is a question of debate with the minister. I do not want to prevent his making that point, but at first glance it does not appear to me to be a question of privilege.
