residency is not applicable to corporations in the same manner as it is to individuals. The taxation of corporations is determined by their place of business. However, over one-half of taxable income is earned by corporations which operate in more than one province. The financial accounts of corporations are not broken down by province. Nor do separate tax accounts exist by province. Taxable income for provincial corporate income tax purposes is allocated according to a formula which generally distributes income in proportion to the shares of wages and salaries paid by each corporation in a province and the corporation's sales in the province. While this formula clearly does not necessarily reflect the provincial incidence of the tax expenditure itemized, the following distributions of taxable income for the manufacturing sector and the resource sector provide some indication of the provincial pattern of corporate activity in these sectors.
