MacKay (Solicitor General of Canada): (a) and (b) Ministry Secretariat 8 (Employees—one under contract); National Parole Board, one (board member); Royal Canadian Mounted Police, 59 (public servants and 195 members of the RCMP); Canadian Security Intelligence Service, 7 (employees); Correctional Service of Canada, 5 (employees under contract).

(c) Ministry Secretariat, \$296,604; National Parole Board, GIC-5, \$58,620 to \$68,990; Royal Canadian Mounted Police, \$7,630,600; Canadian Security Intelligence Service, \$201,500; Correctional Service of Canada, \$72,750.

The House resumed consideration of the motion of Mr. Axworthy:

That this House condemns the Government for undermining the will of Parliament and the Legislatures by failing to use industrial, decentralization, agricultural, transportation and equalization policies as well as its Crown Corporations to further economic development in all communities across Canada.

Mr. Claude Lanthier (Parliamentary Secretary to Minister of Finance): Mr. Speaker, I am quite pleased to rise in the House and to deal perhaps in a somewhat brief but no less confident way with the rather unexpected issue we must address today. The purpose of this ill-advised motion is to condemn the government for undermining the will of Parliament by failing to use equalization policies to further economic development; that is in part how the motion moved by the Hon. Member for Winnipeg-Fort Garry (Mr. Axworthy) reads.

Mr. Speaker, I strongly object to this motion which I find without either rhyme or reason. Moreover, I find it passing strange and somewhat paradoxical that a few weeks after having fully debated in this House Bill C-39, to provide for the making of supplementary fiscal equalization payments, and at a crucial moment when the Standing Committee on Finance, Trade and Economic Affairs is called upon to consider this equitable and fair legislation, that the author of this bizarre motion has the audacity to put forward such a motion, or perhaps is it due to a lack of understanding of the Parliamentary system.

Since he appears so anxious to deal with the subject-matter of Bill C-39, I hope to meet him shortly during the forthcoming meetings of the Standing Committee on Finance, Trade and Economic Affairs, if his party appoints him as a substitute for the next few weeks. I am really eager to see him get together with his friends, the members of the old guard of federal politics, the self-appointed champions of Manitoba interests, who have the gall to condemn the government of Canada for providing Manitoba with \$115 million in total supplementary fiscal equalization payments.
