The Chairman: When we get to the schedule, as hon. members can see, the department has presented some amendments to schedules I, II and III. Beauchesne's tells us that when a bill is introduced, to give effect to an agreement or confirm a scheme, the text of which is contained in a schedule to the bill as an independent origin and status of which is described in the introductory provision of the bill, amendments cannot be made to the schedule.

If members look very closely at what the amendments do propose, it is really a technical amendment in the translation. It was really an error of translation and not a change in the schedule itself which is why we have agreed to make those changes.
