CELEBRATION OF ONE-HUNDREDTH ANNIVERSARY OF ARRIVAL OF FIRST JAPANESE IMMIGRANT TO CANADA

Hon. Joseph-Philippe Guay (Minister of State (Multiculturalism)): Mr. Speaker, beginning this week, Canadians of Japanese descent across Canada will be celebrating the onehundredth anniversary of the arrival of the first Japanese immigrant to this country.
