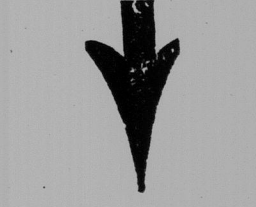

NEW PURCHASING ORDERS LIFT STOCK PRICES

Are Caused By Favorable Tone of Latest Industrial News

GAIN MODERATE IN WALL STREET

Montreal Trading Fairly Active As Day's Business Begins

NEW YORK, April 7.—(Opening)—New buying orders appeared in the stock market today in response to the favorable tone of the latest industrial news, lifting prices moderately higher at the opening. Renewed short coverings also contributed to the initial upward movement, which included Baldwin, Allied Chemical, United Drug, Crucible Steel, Studebaker and a variety of other motor shares.

MONTREAL MARKET.—Trading on the local stock exchange at the opening this morning was fairly active and values recorded several losses and gains. Brazilian, Smelters and Power were the most active issues. Brazilian opened at 92 1/2 for a gain of 1/2 point. Smelters was the strong point and was marked up at 212 for a gain of 1/2 point, while Power at 22 1/2 gained half a point, but both dropped to 22 1/2 and proved to be the weak spot of the early trading. Morning Stock Letter

NEW YORK, April 7.—The market continued to move ahead in a slow and stable manner. The short interest, which is not as large, of course, as it was a week or so ago, nevertheless is widely scattered and consequently weak. Subject to some irregularity, we believe the rally will continue, although it is getting near a point where some test may be made. Yesterday afternoon there was a tip passed around that a bear attack would be made today on the motor shares. This may come, and if it does, it will show well the present condition of the market. We think any attack right now will run into considerable support, and that before the week is over leading stocks will rally to higher prices. With some possibility of favorable developments in general motors within the next four or five weeks, we believe it can be bought on weakness. Of the leading issues, U. S. Steel seems to have a constant demand, although, as is usually the case, it moves smaller than the volatile stocks. Recent operations indicate the earnings statement of this month will be highly favorable. There are reports in good circles that St. Louis Steel has acquired the controlling interest in Woodward Iron, its chief competitor. Some circles likely will sell much higher. St. L. and So. Western was sold yesterday and we think it will show further advance on both possibility of a 45 dividend rate and very favorable terms in the merger with M. & C. and K. S. L. So. Ry. C. & O. and N. Y. C. are all selling at fairly active prices.

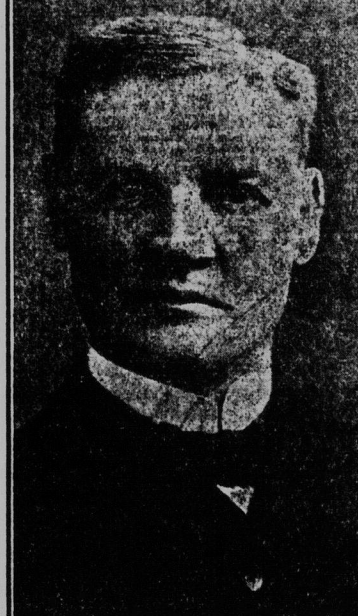

GEORGE CARVILL

George Carvill, who is offering for a Commission, is a son of the late George Carvill, of Newry, Ireland, who with his brother William H. Carvill, came to Saint John in 1836, to open a branch of their iron, lumber and shipping business.

Mr. Carvill, who is a native of Saint John, received his early education at the Christian Brothers' and later at Stonyhurst College, Lancashire, England, and Georgetown University, Washington, D. C.

After leaving college he entered his father's office and upon the death of the latter carried on the business with his brother William H. Carvill, under the name of George Carvill & Sons.

For some years Mr. Carvill held the position of French consular agent, succeeding his father and brother in that capacity. After retiring from business Mr. Carvill became city ticket agent for the C. N. R. At the present time he is engaged in real estate and is owner and manager of the Carvill Hall properties.

Mr. Carvill is a booster and his slogan is: "Reduce our taxes, and increase our resources by the development of Courtenay Bay."

To the Electors of Saint John:

Ladies and Gentlemen: In making your support for my re-election to the office of Commissioner at the forthcoming election, I am reminded that when I last appeared to you for your support at the polls, I promised, if elected, to do everything within reason to merit your confidence and support. Let us not only advertise our resources and talk properly about more business, but go out and get after it. To be sure, we are dependent upon favorable action by the Government in Ottawa for the development of the port. Extensive work has been too long delayed. This cannot be too strongly emphasized. More accommodation will give the ships the berths they prefer, more facilities and more freight will bring shipping, more work, more business, and a "bigger city." We can multiply our wealth and double the business of the port. It requires some energy to obtain this. In this and all policies, I contend for, I am fighting for Saint John.

Furthermore, it is readily admitted, provided a man has honesty and ability to begin with, the longer your representative serves at City Hall, the more valuable his services become to the community. I therefore appeal to the best element in the City for their loyal and hearty support.

\$1,000 BAIL GIVEN

Amherst Man is Charged With Perjury in Liquor Case

AMHERST, April 6.—Held on a charge of perjury, Leslie Hatherley, of River Hebert, appeared before Magistrate MacKenzie this morning and was remanded for a further hearing until Friday. Bail was granted, the amount being fixed at \$1,000. Hatherley appeared in the police court on a charge of being intoxicated and on being questioned in regard to the source of supply, informed the court that he had brought a bottle from some man in the vicinity of the station, the man being absent for 20 minutes and then returning with the liquor. Contrary information was secured by the N. S. T. A. Inspector, A. G. Tuttle, and a perjury charge was preferred against Hatherley.

SERVED SAINT JOHN IN TRYING YEARS

Editorial Comment on Dr. W. W. White's Retirement From Mayoralty in 1906

(Saint John Globe, April 30, 1906.)

Dr. Walter W. White, who retires from the Mayoralty on Tuesday, has occupied that position for four consecutive years. The citizens cannot but feel that Dr. White has amply repaid them by his public services for the confidence which they have generously given him. In four years of public life, a man having many duties to discharge, many important acts to perform, many questions to settle, cannot be expected to do all that he had to do in such a way as to please every critical citizen in a city in which there is so much independent thought and so much free expression of thought of that kind as there are in Saint John. But looking back over the four years, even the most critical will cheerfully admit that Dr. White has carefully studied the interests of the city and has conscientiously sought to advance the interests of Saint John. The four years of his Mayoralty have been trying years, for the city had embarked in many enterprises, almost all of which were the natural result of pre-existing causes. To go on, at least so far as some of them were concerned, may have been doubtful; not to go on was almost impossible. So far as the Mayor was concerned, he ever showed the reasonable judgment and moderation of speech and action which exhibit a thoughtful mind and conscientious responsibility. He sought to rule the city according to the laws which are provided for its government, and never exhibited any desire to impose his own views upon the community by any other force than that supported by reason. He can lay down the gavel with the consciousness that whatever differences of opinion may exist as regards this particular act or the other, his integrity has never been challenged, and that his course as a whole is fully appreciated by his fellow citizens. He may be allowed to retire from public life, but this is most improbable. Those duties which are connected with the Mayor's office which are of a social and hospitable kind, have been generously performed by the Mayor; and it is not, perhaps, out of place to say that in the discharge of these he has been efficiently helped by the excellent and amiable woman who presided over his household, and who in her position as wife of the Mayor of Saint John, has all the pride, all the sense of responsibility, all the good feeling of a hospitable host, which the himself could feel. To both of them in this regard the city is a large debtor.—Advt.
