NEW YORK, Aug. 13.—"Canadians are made of good stuff," was the comment of a bystander who learned the nationality of Patrick Mongeon, a guard on the Hudson Manhattan tube, while Mongeon's foot, caught between two cars, was being amputated.

For three-quarters of an hour attempts were made to release Mongeon, while he smoked cigarettes and joked with his would-be rescuers. No anesthetic was used when the foot was caught off, and last night Mongeon was in a critical condition.

Abbe Gilles Declares "Maria Chapdelain" is Dangerous to Public Morals.

QUEBEC, Que., Aug. 13.—Rev. Abbe Gilles, a French priest, who has just returned from a visit to the Lake St. John district described in Louis Homan's famous novel "Maria Chapdelain," declares the book should be condemned as dangerous to public morals.

Abbe Gilles has written to Monsignor Beaudry, Bishop of Montreal, and Monsignor Labrosse, Bishop of Chicoutimi, asking them to use their influence to have the book condemned.

ASK RESIGNATION Sydney Reserve Local Demands U. M. W. District Officials Quit Offices.

SYDNEY, Aug. 13.—Reserve local of the United Mine Workers of America, which voted for rejection of the Government proposal under which the coal strike in Nova Scotia was ended last week, yesterday adopted a resolution calling upon the executive officers of District 26 to resign from office.

Many Casualties in Chinese Disorders

TIEN TSIN, China, Aug. 13.—Eight persons were killed and about 50 injured in the firing yesterday by Chinese guards into a crowd which had gathered at the scene of the previous day's rioting by striking mill workers. It is believed that several persons were drowned when they jumped into the Kaibo River to escape the bullets of the police.

TO HEAR REPORT. PARIS, Aug. 13.—Premier Painleve has called the cabinet council to meet at nine o'clock this evening to receive from Foreign Minister Briand, who reached Paris from London, a report on the result of his conversation with the Foreign Secretary Chamberlain on the proposed security pact with Germany.

BISHOP EXCOMMUNICATED. NEW YORK, Aug. 13.—Bishop Adam Philipovsky, now in jail for contempt of court, for forcibly taking possession of the Russian Orthodox cathedral, has been excommunicated with 15 of his followers by a synod of more than 70 bishops and priests of the Russian Orthodox church.

HURT IN COLLISION. NORTH ADAMS, Mass., Aug. 13.—Several passengers on a motor bus bound from Albany to Boston, were taken to a hospital here today after being injured in a collision between the bus and a truck loaded with sand. It was believed that all would recover.

KILLED BY HORSE. BARRIE, Ont., Aug. 13.—Wm. C. Thompson, farmer of Essex Township, died today. He was leading a horse to water, when the animal reared and struck him with both fore feet on the head, causing fracture of the skull.

NEGRO LYNCHED. SOBBY, Miss., Aug. 13.—Sidney Towns, negro, who was being held in connection with the deaths of Jacob McMillan, 65, farmer, and Mrs. Mary Long, 70, was taken from Eberett Post here last night by a mob of approximately 75 men and shot to death.

ESKIMOS BROADCAST. CHICAGO, Aug. 13.—Belknap in Etah, Greenland, last night gave a radio program by radio, which was heard in Chicago. The Eskimo program was broadcast on a 40 meters wave length from station WAP aboard the S. S. Peary, ship of the MacMillan expedition at Etah.

WASHINGTON, Aug. 13.—A formal communication pressing for the return of German property seized by the United States during the war, was presented to Secretary Kellogg by the German ambassador. No comment was available at the State Department. The text has not been made public, but the memorandum is understood to point out that in view of the status of the operations of the Dawes reparations plan, and the benefit to be derived from those payments by the United States, the time appears appropriate to take up for settlement, the question of German properties still held by the Washington government.

LONDON PAPER IS CRITICAL OF ALL BUT HORNE

Particular Objection Is Taken to Communist Member WORDS QUOTED Express Fears Views of Visitors Interpreted as British Opinions

British United Press. LONDON, Aug. 13.—Lord Beaverbrook's Daily Express has begun a campaign against the personnel of the British parliamentary and former parliamentary delegates who are going to Washington in October for the International Parliamentary Union conference there. The only one who meets with the newspaper's approval is Sir Robert Horne, who was Chancellor of the Exchequer in Lloyd George's Coalition Government.

The other delegates the newspaper described as scoundrels who, it declares, have no authority or reputation which entitles them to speak on serious topics in this country's behalf.

QUOTES COMMENTS The name of Shapurji Saklatvala, Parsee Communist member of Parliament on the left, especially arouses the Express' wrath and Wednesday it published extracts from his speeches such as: "Let us abolish the Union Jack. The Union Jack is the symbol of enslaved labor all over the world."

"The British Empire is made up of aristocracy, and the cunning, dirty dog of a man who will sell any one's country at any time."

"The British Parliament's chief function is to make laws which are a partnership in guilt and robbery. The Empire is an empire of agitation and dishonesty to all British workers."

"I am a man with a great affection, regard and esteem for Lenin."

FEARS MISINTERPRETATION Saklatvala, when asked if he anticipated any objection by the United States to his visit because he is a Communist, replied: "I don't for a moment expect the United States government to be so childish as to interfere with the expression of the opinions of Great Britain, and the Empire urges the admission of four or five more members of Parliament of world-wide reputation."

LIGHTNING KILLS BOY, HURTS GIRL Strikes Tree Under Which They Had Taken Shelter From Storm.

ST. RAPHAEL, Que., Aug. 13.—Eugene Roy, aged 7, was instantly killed and his younger sister was probably fatally burned yesterday when lightning struck a tree under which they had taken shelter during a storm. The little girl is terribly burned about the face and body, and little hope is entertained that she will recover.

BRIAND LEAVES LONDON. LONDON, Aug. 13.—Foreign Minister Briand of France who has been in London since Monday night, engaging in conferences with the British Foreign Secretary, Right Hon. Austen Chamberlain, on the security and guarantee questions, returned to France this morning.

Spanish Miners Object To British Subsidies

GIJON, Spain, Aug. 13.—Coal miners and owners have held several meetings here to protest against the action of the British government in granting subsidies for coal exports. They believe this policy will cause serious damage to the Spanish coal industry.

MOTHER SHOTS HUSBAND, SELF, TWO CHILDREN

Parents Dead, Children Believed to Be Dying ONLY ONE ESCAPES

West Roxbury Woman, Thought Insane, Daughter Tells of Tragedy

Canadian Press. BOSTON, Aug. 13.—George H. Curtis, of the West Roxbury district, and his wife, Mary, are dead, and two of their three children are believed to be dying at the City Hospital of bullet wounds in the head. A daughter, Dorothy, the only member of the family who escaped injury, told the police her mother shot the others early today, in a fit of desperation, and committed suicide.

George H. Curtis, 37, 29 years old, and Marjorie, seven years old, were shot while they slept, their sister said. Dorothy reported that she escaped because she slept in a room on the second floor, and she was awakened by the sound of her mother's shouting after 1 o'clock this morning.

FRENCH DEBT SOON SETTLED IS BELIEF

London Paper Says Progress Made—Brund Denies Discussion in London.

STOWAWAYS JAILED Three Jump From Ship in Halifax; One Swims to Freedom.

Canadian Press. HALIFAX, Aug. 13.—Three stowaways made an attempt to escape from the Munson liner Muncaster just before the steamer pulled away from the dock for Boston yesterday. One jumped into the harbor and swam to safety among the piles of the waterfront. Two others jumped from the rail to the dock and were rounded up by immigration officers. The two captured youths will be returned to St. John's, Newfoundland, where they boarded the steamer.

Kemal Gets Divorce

MUSTAPHA KEMAL PASHA was married January 29, 1923, to Latife Hanoum, daughter of Mousamerou Chaki Bey, wealthy merchant of Smyrna. The marriage is said to have brought him a dowry of one million Turkish lire. A few months later, Latife, known as an exponent of women's rights, was proposed as a deputy to the Turkish Parliament from Constantinople by women of that city, who were indignant over the unsatisfactory proposal of Deputy Salih Effendi to make marriage obligatory.

Madame Latife was 19 years old at the time of the marriage. She was described as a dainty, attractive girl, with large black eyes. The dowry of one million Turkish lire which Mustafa Kemal Pasha brought her husband was worth approximately \$650,000 at the rate of exchange at that time.
