Goethe, musical director of the public school, Mr. Jordan says he learned that the average pupil knows very little about a symphony orchestra, and he is offering the scholarship to encourage greater interest in the matter on the part of pupils in the London schools. Local newspaper editors, along with Mr. Goethe, are to be the judges, and the essays, which must be written without assistance, and not over 800 words in length, must be in the hands of Mr. Jordan not later than February 25.

STEVENSON SEEKS TO APOLOGIZE FOR AGENTS OF EDUCATION BOARD
London Labor Member Feels Called On To Apologize To Minister of Education Because of Alleged Improprieties of Members of London's Board While in Toronto—London Bill Gets First Reading.

(Special to The Advertiser.)
TORONTO, Feb. 16.—Because of certain alleged improprieties committed by the London Board of Education when that body was waiting on Hon. R. H. Grant, minister of education, in his office several days ago, Mr. Stevenson, London labor member for London, has felt called upon to apologize to the minister.
While the member for London was not inclined to discuss the alleged improprieties of the school board, he felt that necessary London educational legislation might receive a "black eye" in the Commons. Even so, he divided on the issue as to the proper site for a new school building in London, the board came down to Toronto twelve strong to seek the minister's advice. He told them it seems to build the school where public opinion demanded that it should be built.
Left Minister's Office.
Having left the minister's office to visit another Parliament Buildings office, it is said, the board members returned to Hon. Mr. Grant's office, when they found him not in, demanded of the secretary, it is said, that he was to be brought back to the office. When informed that the minister was in executive council, board members are said to have exclaimed: "Get him out. They are only farmers' boys."
When the minister of education afterwards heard of the incident, he is said to have expressed extreme indignation over the board's actions. Dr. Stevenson, the London member, who would today be would, if necessary, apologize on the floor of the Legislature. He thought some London public body ought to apologize on behalf of the city.
London Bill Introduced.
London bill authorizing a commission form of municipal government was introduced into the Legislature today by J. A. Calder, Liberal, North Oxford, and was given first reading. The preamble of the bill sets forth that the electors of the city of London have already passed on the proposal, and that the bill is accordingly to the measure, the council shall be composed of a mayor and eight commissioners, and to hold office for a two-year term. The four commissioners receiving the highest number of votes for two years, and the other four commissioners for one year.
Included in the city of London bill is a definition of the duties and powers of the commission, and the request for legislation to borrow various sums of money for storm sewers, extension of waterworks and electric light plant, for London railway, commission for memorial hospital for children, home for incurables and children's hospital.
That the \$300,000 deficit which Hon. Peter Smith has announced for the Ontario Legislature would be treated very seriously by the people of the province was an opinion advanced by Charles McCrea, Conservative, Sudbury, in the budget debate in Ottawa. He charged the provincial treasurer with covering up an actual deficit of \$1,000,000.
W. E. Sinclair, Liberal, South Ontario, continuing his address, declared that either the U. F. O.'s big noise about lawyers legislating for the province was political propaganda, or else the farmers had been proven to be unable to legislate for farmers. He gave the farmer members in the House credit for having introduced the greater part of all measures dealing with agriculture, and the 8 1/2 per cent, or 6 of 24 bills.
The member for Sudbury contended that the provincial treasurer's book-keeping system was in error. To the ordinary expenditures submitted by Hon. Mr. Smith, he added the sum of \$144,891, and of three items which he said had been wrongly put in capital. These items were: Railway annuities, \$240,000; training veterans as teachers, \$18,425; and Soldiers' Aid Commission, \$60,000. Railway expenditures, he said, had always been treated as current expenditures under the old Government.
Both Mr. McCrea and Mr. Sinclair were firmly convinced that the Farmers' Government would have to ease up in the matter of expenditure of public funds.

RAPS RANEY REGARDING O. T. A.
TORONTO, Feb. 16.—Re-opening the debate on the budget in the Ontario Legislature today, W. E. Sinclair criticized the attorney-general for the way he had undertaken to give instructions to magistrates concerning the Ontario temperance act. He suggested that the attorney-general apply his energies to investigating the high price of coal, the reason why Ontario is being sold at twenty cents a pound less in England than it is in Ontario, and the question of combining juvenile crime.
The member for North Ontario attributed rural depopulation to several causes, laid in birth rate, the desire of farmers to come to the city for educational purposes and the introduction of machinery. Despite the large number of commissions already appointed by the Drury cabinet, he thought it would be a good idea for Government to appoint a commission to investigate the causes of rural depopulation and the general agricultural depression.
Taken Snap at Tolmie.
R. M. Warren, U.F.O., North Renfrew, said that the O. T. A. was a law that had received the undoubted approval of the electors of the province, and, therefore, should be firmly enforced, despite the opposition of a third of the minority, and unscrupulous doctors should be not only fined but given a stiff jail sentence.
The member for Renfrew said he had not expected that for the member for Windsor (Major J. C. Tolmie) because of his calling, would have criticized the O. T. A.
Major Tolmie promptly denied that he had uttered one word of criticism of the O. T. A. He had simply objected to the way it was being administered, he said.
Dealing with the question of unemployment, the member from Renfrew said that the member from South Brant (M. M. MacBride) in his speech the other day had "almost incited men to pillaging and looting," and such utterances ill-became a member of the Legislature.
MacBride Replies.
"The honorable member has suggested that my remarks possibly savor of socialism," said Mr. MacBride, "my reputation throughout Canada is that of a moderate labor man." He asked that the honorable member withdraw his remarks.
"That's not the point," said Hon. G. Howard Ferguson, intervening. "The honorable member for South Brant has denied a statement attributed to him, and the member for North Renfrew is bound to accept the denial."
"I want to make it plain to every member of this House that when an honorable member denies a statement his denial must be accepted," said the speaker. "That is only what can be expected of gentlemen."
Attacks Bluffs Policy.
Hon. George S. Henry, Conservative, East York, bitterly attacked the highway policy of Hon. F. C. Biggs as wasteful and inefficient. He said it was a "crying shame" that the Government should be paying 20 per cent in some municipalities doing their work under statute labor. Costs of road work performed in York County, he said, were unreasonably high. And there was absolutely no justification for leasing bonds for 20 years on gravel roads in the province. They should be paid for out of motor license taxes.
The member of East York criticized the action of Principal Reynolds of the Ontario Agricultural College at Guelph, who "could not get away from the narrow groove he was brought up in."

Albert Burling and William Badour, merchants, whose stores were entered, said that they had known the boys for ten years and had always found them honorable. They did not wish to press for a sentence.
Crown Attorney J. B. McKillop stated all the facts of the case to Judge Macbeth, after which the judge said that if the offence had been a second one, or the boys had had any black marks against them he would have sent them to the penitentiary. Suspended sentence, he thought, was out of the question. It was a more aggravated offence when a crime was committed in a small municipality where there were no police to cope with it than in a large city where an efficient police force was stationed. Both War Veterans.
Both boys had been overseas, one of them having served with the Canadian Siberian Expeditionary Force in Russia.
Albert Burling, a clothing merchant, stated that early Saturday morning 445 worth of goods had been taken from his store. Entrance had been gained to the building by the breaking of a window.
William Badour, a shoe merchant, said that 225 worth of shoes had been taken from his place. The thieves had got into the store by breaking the window in a rear door.

The total value of Canadian exports and imports for the month of January, 1921, was \$154,186,081. For January, 1920, this figure was \$225,096,920, so that a comparison between the two months shows a decrease in trade value amounting to \$70,910,839.
