PRAYERS.

The following Petition was brought up and laid on the Table :

Ry the Honorable Mr. *Olivier*; of *Pierre Cazabon* and others, of the Electoral Division of *Berthier*.

Pursuant to the Order of the Day, the following Petition was read :—

Of the *Niagara* District Bank ; praying for the renewal of their Charter.

The Honorable Mr. *Allan* moved, seconded by the Honorable Mr. *Macpherson*,

That the Sixtieth Rule of this House, viz :—“ 60. No Committee on any Private Bill originating in The Senate, of which Notice is required to be given, is to consider the same until after a week's notice of the Sitting of such Committee has been first affixed in the Lobby ; nor, in the case of any such Bill originating in the House of Commons, until after “ twenty-four hours' like notice,” be suspended for the remainder of the Session.

The question of concurrence being put thereon, the same was resolved in the affirmative, and

Ordered accordingly.

The Order of the Day being read for the consideration of the Eighth Report of the Joint Committee of the Senate and House of Commons on the Printing of Parliament.

The Honorable Mr. *Sanborn* moved, seconded by the Honorable Mr. *Simpson*.

That the said Report be adopted.

After a long debate,

The said motion was, by leave of the House, withdrawn.

A Message was brought from the House of Commons by Mr. *Bowell* and others, in the following words :—
