Blenkarn, Cardarelli — THELAW plancourtshowdown

Don Blenkarn and Ettore Cardarelli had each other exactly where they wanted each other yesterday - in court

No sooner had Cardarelli filed a writ in Peel County Court last week, charging Blenkarn with improperly voting in November's municipal election, than the former Mississauga MP filed a notice of motion asking that Cardarelli, a defeated Ward 1 council candidate, appear in court yesterday.

"I want to go ahead with this thing as quickly as possible," said Blenkarn,

a lawyer for 25 years with the Port Credit firm of Blenkarn, Roche, Kerr and Shadlocke. "I want an immediate trial to get this thing out of the way."

Both men appeared in court yesterday to "set the ground rules" for the action, ask for direction as to how it should proceed and to set the Feb. 19 court date.

Blenkarn told The Times Saturday morning the writ Cardarelli filed was "improper," but he ignored its errors because "we want to get on with it." He said Cardarelli did not complete the address and service information on the back of the writ

Blenkarn is the Progressive Conser-

vative candidate in Mississauga South in the upcoming federal election:

According to Cardarelli, a director of Peel Region Social Planning Council, Blenkarn has been charged in the civil suit under Sections 96-B and 96-C of the Municipal Elections Act.

The Port Credit resident alleges that Blenkarn voted twice, once in the Mississauga ward where he lives and once in the ward where his office is located — a ward he had no privilege to vote in on Nov. 13.

Cardarelli does not plan to use a lawyer because "it doesn't appear I'm going to need one." However, he plans to call witnesses

Shipp pays festival debt

Developer Harold Shipp, past chairman of the 1978 Mississauga Community Fritterfest Festival, has paid the Fritterfest's \$43,000 debt.

Shipp issued a cheque to the festival committee from his corporation Thursday evening. He has postdated it to Jan. 31 in anticipation of what may take place at city council when an audit of the committee's budget and a final report are presented.

"I'm sick and tired of having my name and the committee bashed through the press," he said when asked why he paid-the debt. "If there is ever going to be another successful Fritterf est, or any festival next year, the way must be made clear now so the new committee can get on with it." The first Fritterfest was held last vear

Shipp said he took the initiative away from Mayor Hazel McCallion when he paid the debt.

"She expected I was going to come before council with my hat in my hand — begging," Shipp said.

"She's playing Joan of Arc. She's trying to show the taxpayer who's running the city and this happens to be one of her first issues. She's mad as hell about what I did.'

McCallion said it was a "verygenerous offer" and that there "aren't too many that would do it."

The mayor said it is going to take a few years for Fritterfest to catch on and she would like to see the festival continue, "if it doesn't cost too much

money." The city treasurer has accepted the \$10,000 cheque from the committee,

the amount of the loan made to the committee last spring.

"It was understood that this was a loan, not a grant," McCallion said. "They never asked the city for a grant - they may yet. I think it's honorable that they repaid the loan. I also think it's honorable that the committee is looking for a way to repay the debt.'

McCallion stressed the fact that because the committee is incorporated, it must incur its own debts.

Ward 3 councillor Frank Bean said the \$43,000 payment is not the solution. "He shouldn't have to pay the debt," Bean said of Shipp.

"There aren't too many taxpayers who want to pay," he said. "They shouldn't have to. The committee will have to come up with a plan.'
