Mr. Scott, who is retiring from the farm and moving to Havelock, spoke in reply, and also in Mrs. Scott's behalf assuring those present of his gratitude for their kindness and his warm appreciation of them all.

Shareholders May Get 66 Per Cent.

According to the deductions of Mr. Master, solicitor to the Government investigator, Mr. W. H. Cross, the total liabilities of the York Loan & Savings Company to the shareholders amount to \$3,178,768. The assets as arrived at during the examination are \$2,040,634. The deficit, therefore, is \$1,138,134, or nearly one-third of the total indebtedness. With other allowances included the deficit would probably be reduced to \$1,000,000. It is therefore assumed that the company will be able to pay only 66 cents on the dollar.

The evidence taken showed that from 1896 to August 19 last the company had received on installment shares, \$6,225,187, whose face value, including \$100,000 stock on hand, was estimated at \$8,081,000. The payments to shareholders, including losses, during that period was \$5,577,067.

A number have already sent in their books, and all shareholders in this vicinity should send their books in as soon as possible.
