A hose connected with the tank-hydrant made all the water available, and this, happily, was instrumental in keeping the fire within limits. The citizens congratulate themselves on the narrow escape the town had.

The Houston building was worth about \$1,800; insured for \$1,000, stock insured for \$2,800, but this will by no means cover the loss. The Clanahan block is fully insured; loss nearly \$1,000.
