THE RAILWAY STRIKE.

Archbishop Ireland Blames Labor and Praises Cleveland's Action.

A Man May Cease Work But Has No Right to Coerce Others.

CHICAGO, July 17.—Archbishop Ireland, of St. Paul, being asked what he had to say on the railway strike said:

"I dislike to speak of the strike, because in so doing I shall blame labor, while, because of my deep sympathy with it, I should wish to have never said but words of praise. But in a moment of social crisis, such as the one through which we are passing, it is a duty to speak loud and to make avowal of the truths and principles which will save society and justice."

A CLIMAX REACHED. LONDON, July 17.—There is chronic discord in the Irish land committee, which reached a climax yesterday. Rt. Hon. John Morley, who is chairman of the committee, sustained a witness in refusing to read the whole of a letter in regard to the settlement of a land case. Messrs. Broderick and McCarty sided with Mr. Morley on a division of the question, but the majority voted that the entire letter should be read, whereupon Mr. Morley summarily adjourned the sitting, saying that he must consider the matter of retaining his position as chairman. The affair created a great sensation in the lobbies of the House of Commons. Mr. Morley Healy declared that if Mr. Morley is absent from the next meeting of the committee he will move that Mr. Sexton take the chair. It is expected that the same similar action will break up the committee.

FEW STRIKE INDICATIONS. SEATTLE, July 17.—From the appearance of the railroad yards yesterday a casual observer would see nothing to indicate that a great strike was in existence. Freight and passenger trains left and arrived regularly on the Lake Shore road, and passenger trains on the Northern Pacific were on time. The freight business is quite another thing. Considerable trouble is being experienced to get that line of the country in working order. "The facility with which it will be done will depend a great deal on the action of the engineers at Tacoma," said one official. "Should they return to work we will have but little trouble. If, however, they refuse we will be put to the delay and annoyance of breaking in new men."

TO BE TRANSPORTED. ROMA, July 17.—In the senate yesterday the government's anti-anarchist bill was approved without debate. Premier Crispien announced, amidst shouts of approval from all parts of the chamber, that the most dangerous of the anarchists under conviction and those subsequently convicted, would be sent to an island in the Red Sea to be confined. Some anarchists prisoners, he said, had already been sent there. Signor Crispien added that the government agents had left for England to assist the authorities in that country in identifying anarchists and keeping them under surveillance.
