opponents-I admit-referred to it more than we did, they had need to do so in order to attain their political purpose. So as not to alarm public opinion or discourage those who were out of work, we preached optimism, while our conservative opponents preached pessimism.

However, through the irony of fate, when, today, conditions have become much worse, hon gentlemen opposite are shocked because we do not agree with them and state: "All is for the best; conditions are improving, wait, do not lose heart, in two or five years, the agreements we have entered into with England will give excellent results." Hon. gentlemen opposite are simply jokers, and the people await the opportunity to rebuff them as they deserve. Then, our beautiful country, under a Liberal administration, will again enjoy an era of happiness and prosperity. And, as a reward for the great services rendered to the empire, the present leader of the government will be given a well padded seat in the House of Lords, in England.
