pending the holding of an immigration inquiry to determine his right to remain in Canada.

Concurrently with this action prosecution proceedings were instituted by the police authorities. He was charged with illegal entry into Canada and appeared in court on May 4, his case being remanded. The court granted his release on bail of \$1,000. Notwithstanding the court's acceptance of bail, Vergakis continued to be detained for the immigration inquiry which was opened on May 6. The inquiry was immediately adjourned at the request of Vergakis' counsel, and he was released. Because of different adjournments, occasioned in part by Vergakis' refusal to answer questions, the inquiry was not completed until June 14, at which time he was ordered deported. He has entered an appeal against this order.

In the light of the deportation order and the fact that Vergakis is a deserting seaman, the special inquiry officer decided that he should be detained. The next day, an application for release having been made to the special inquiry officer by Vergakis' counsel, the detention order was withdrawn. He is free pending the outcome of his appeal and trial. The trial is scheduled to take place on June 26.

Mr. Reid Scott (Danforth): A supplementary question to the Prime Minister. In view of the continuing series of reports and statements in connection with the Immigration Act and the alleged denial of the rights of individuals, would the Prime Minister not consider having a committee of parliament examine the Immigration Act with a view to clearing the air in a lot of these matters?

Right Hon. L. B. Pearson (Prime Minister): Mr. Speaker, before considering that matter, I think it would be well to await the conclusion of the discussion which will undoubtedly be taking place on this matter on interim supply.
