#### FLOODS

TRAIL, B.C.—STATEMENT BY MINISTER RESPECTING FINANCIAL AID

Mr. Randolph Harding (Kootenay West): Mr. Speaker, I wish to address a question to the Minister of Public Works. In view of the urgent need for the Trail committee to know what finances are available to them for rehabilitation after the recent disastrous flood, could the minister indicate to the house when he could make a definite statement on the federal government's contribution to the disaster fund?

Mr. Sharp: Yes, Mr. Speaker, I assured the [Translation] Finnish ambassador that we were very interested and that we would carefully and seriously explore the suggestions. It is the Canadian view that questions of European settlement are very urgent. Our only concern is that any proposed conference should succeed, because an abortive meeting would be worse than useless.

Mr. J. Edward Broadbent (Oshawa-Whitby): As a supplementary question, Mr. Speaker, could the Secretary of State for External Affairs inform the house whether the Canadian government has encouraged other members of NATO to respond in a way similar to that of the Canadian government?

Mr. Sharp: Yes, Mr. Speaker, I think I did say to the house, when I was asked originally about the NATO meetings, that that was the position taken by Canada and was responded to very constructively by the NATO powers.
