#### **PETITIONS**

MR. MURPHY—TAXATION OF NORTHERN ALLOWANCES

Mr. Rod Murphy (Churchill): Madam Speaker, my petition today is in regard to the taxation of northern benefits and northern allowances. The petitioners, who are supported by the Canadian Teachers' Federation, oppose the taxation of these benefits. They point out the high cost of living in northern communities, the high cost of travel, transportation costs, living costs, etc., and ask that the Government, through the House of Commons, rescind its decision to tax these benefits.

### MR. ANGUISH—FRESHWATER FISH MARKETING ACT

Mr. Doug Anguish (The Battlefords-Meadow Lake): Madam Speaker, I am presenting a petition to the House of Commons today signed by fishermen from the Athabasca Basin region, consisting of that area and communities such as Camsell Portage, Uranium City, Fond-du-Lac, Black Lake and Stoney Rapids. They are requesting that they be allowed to opt out of the Freshwater Fish Marketing Act which they say has practically destroyed their industry in this far northern area. There is documented evidence here to back up that allegation.

I would like to say that I have been attempting to meet with the Minister of Fisheries and Oceans (Mr. De Bané) concerning this petition since January 27 to discuss the very important problems outlined herein, but in those two months he has ignored my requests. On that basis, I would hope that this petition will be found in order and referred to the Fisheries and Forestry Committee where it will get its due and proper consideration.

#### MR. LEWYCKY—RETENTION OF CROWSNEST PASS RATE

Mr. Laverne Lewycky (Dauphin): Madam Speaker, this afternoon I am presenting a petition signed by some 205 residents of the federal riding of Dauphin urging the retention of the historical Crow rate. These petitions are presented by people in some 19 places in the Dauphin constituency, and these are in addition to the 1,312 petitions that I presented to this House on June 23, 1982.
