CANADA POST CORPORATION

USE OF FOREIGN MAIL SERVICE BY CANADIAN RESIDENT

Mr. Jim Fulton (Skeena): Mr. Speaker, it is with some regret that I bring to the attention of the House the effects some free enterprisers have upon the costs of Canada's postal service. I have with me today a letter mailed to a Vancouver hospital from Post Office No. 179 in Tijuana, Mexico. The letter carries a 10 peso stamp and a 9 peso stamp. At today's rate of 132 pesos to the dollar, this makes the stamps worth about 15 cents Canadian, less than one half the cost of mailing a letter in Canada to a Canadian destination.

The return addesss on the envelope, which has been carefully concealed by the 9 peso stamp, is Williams and Wilkins, Baltimore, Maryland. The return address inside the envelope is Williams and Wilkins, Box 7220, Ancaster, Ontario. However, on contacting the manager of the Ancaster Post Office today, I learned that there is no Williams and Wilkins in Ancaster, Ontario. That there is no such company in Ancaster was confirmed by Bell Canada. The box, however, is registered to a Mr. John V. Basmajian of 106 Forsyth, in Hamilton, Ontario.

This is an abuse of the postal service of Canada and of other countries, Mr. Speaker. I urge all Canadians who are receiving mail bearing stamps from outside Canada but a return address from inside Canada, to forward the envelopes to Canada's Postmaster, the Hon. André Ouellet, at the House of Commons. By stopping this kind of abuse, we could have a less expensive postal system in Canada.
