It has been approved by the Clerk of Petitions pursuant to Standing Order 106 and is consistent with the almost universal opposition to the deal in Windsor.

The petitioners observe that whereas the trade deal negotiated by the Mulroney Government threatens the very fabric of Canadian political and economic sovereignty by removing the power of the Canadian Government effectively to control foreign ownership, to develop Canadian energy resources in the best interest of Canadians, or to equalize opportunities between the regions, and would deny Canada the policy freedom to determine its own economic future, the undersigned petitioners humbly pray and call upon Parliament to dissolve and allow the people of Canada the opportunity to accept or reject the proposed free trade agreement during a national general election. They suggest that this be on Friday.

**Ms. Marion Dewar (Hamilton Mountain):** Mr. Speaker, I have the privilege and responsibility of presenting this petition from citizens in that very active community of Windsor. The petition says that whereas the trade agreement negotiated by the Government threatens the very fabric of Canadian political and economic sovereignty by removing the power of the Canadian Government to control foreign ownership effectively, to develop Canadian energy resources in the best interests of Canadians, and to equalize opportunities between the regions, therefore the undersigned, your petitioners, humbly pray and call upon Parliament to dissolve and allow the people of Canada the opportunity to accept or reject the proposed free trade agreement during a national general election.

**Mr. Jim Fulton (Skeena):** Mr. Speaker, I also have the pleasure to table in the House a petition certified correct pursuant to Standing Order 106 by a large number of petitioners who are concerned that the Conservative Government had no mandate from the Canadian people to conclude a Free Trade Agreement with the U.S. and they humbly pray that a general election be called prior to any such agreement coming into force.
