## ELIGIBLE U.S. ARMY PERSONNEL ADMITTED TO CANADA

## Question No. 1,845-Mr. Mazankowski:

How many citizens of the United States of America, of an age making them liable for service in the armed forces of their country, were admitted to Canada in 1966, 1967, 1968 and during the first two months of 1969 (a) how many of them have been granted landed immigrant status (b) on what basis are the remainder continuing to reside in this country?

Hon. Allan J. MacEachen (Minister of Manpower and Immigration): In answer to part (a) of the question, in 1966, landed immigrant status was granted to 1,460 United States citizens who were within the draftable age range. In 1967, the number was 1,805, and for 1968, the total was 2,797. No figures are yet available for 1969. Citizens and permanent residents of the United States who enter Canada as non-immigrants are not normally documented. Consequently, no data is available to answer part (b) of the question.

It should be noted that for a wide variety of reasons males in the United States within the draftable age range are frequently exempt from compulsory military service. It is possible, therefore, that some of the individuals included in the above figures might have been in a draft exempt category.

The Dominion Bureau of Statistics has no record of the number of cartons of Canadian cigarettes exported. Statistics on exports of cigarettes are recorded in thousands.
