## \*WHEAT—DELIVERY UNDER CONTRACTS WITH MAINLAND CHINA AND THE SOVIET UNION

## Question No. 54-Mr. Diefenbaker:

1. How many bushels of wheat as of (a) July 30, 1972 (b) December 31, 1972 remained to be delivered under existing contracts with (i) Mainland China (ii) the Soviet Union?

2. At what dates do existing contracts with both Mainland China and the Soviet Union expire?

**Hon. Otto Lang (Minister of Justice):** Mr. Speaker, the answer to the question is as follows: 1. (i) (a) At July 31 110.5 million bushels remained to be delivered against two outstanding contracts with the People's Republic of China, (b) At December 31 98.1 million bushels remained to be delivered against three outstanding contracts with the People's Republic of China, a third contract having been entered into on November 8, (ii) (a) At July 31, 190.2 million bushels remained to be delivered against two outstanding contracts with the U.S.S.R. (b) At December 31 100.1 million bushels remained to be delivered.

2. Existing contracts with the People's Republic of China will have all expired by October 31, 1973. Existing contracts with the U.S.S.R. will have expired by July 31 except for an option to extend shipments of minor quantities of wheat and flour to Cuba to the end of December.
