- 1. Has the Department of the Secretary of State or the Department of Consumer and Corporate Affairs ever asked the Department of National Revenue to investigate the Society for the Study of the Heritage of Canada and (a) if so, for what reason (b) if not, for what reason?
- 2. What form of investigation has been conducted by the Department of Consumer and Corporate Affairs into the affairs and business practices of the Society and what were its findings?

Hon. Mitchell Sharp (President of the Privy Council):
1. (a) Consumer and Corporate Affairs has not requested the Department of National Revenue to investigate the affairs of the Society for the Study of the Heritage of Canada. (b) Consumer and Corporate Affairs had no reason or justification to request such an investigation.

2. Consumer and Corporate Affairs has conducted an accounting investigation into the affairs of the company. Except as noted hereunder, a complete audit of the company's books and records failed to disclose any irregularity or impropriety, including the grants obtained from the Secretary of State. One particular transaction, however, deserves closer scrutiny and the Superintendent of Bankruptcy has requested the R.C.M.P. to investigate.

1 and 2. The Department of the Secretary of State has not asked the Department of National Revenue to investigate the Society for the Study of the Heritage of Canada. The reason for this is that the Society, in receiving funds from the department in previous fiscal years, met the required procedures in submitting budgetary and other necessary information, before and after their projects took place.
