Ms. Copps: Mr. Speaker, I would like to ask the Minister how he can justify the fact that, under the Challenge '86 program, funds have been allocated to a few businesses such as La Ronde, in Montreal, while certain non-profit organizations have been harshly cut off and have been prevented from sending even a few children to the summer camp for handicapped children. Can he justify this conservative policy?

Mr. Bouchard: Mr. Speaker, the Hon. Member for Hamilton East (Ms. Copps) will certainly understand that it would be extremely hard for me to give a reply to such a question this morning. She has quoted facts out of context and without any references and said that funds have been allocated to La Ronde but not to certain non-profit organizations. This is essentially a general assessment. The Hon. Member says that money has been given to some people, but not to others. As for me, Mr. Speaker, I believe that Challenge '86, as Challenge '85 before it, has been a great success. Whatever the Hon. Member may feel, and I am convinced that she is herself happy about it, we have been able to give young Canadians an opportunity to work during the summer, when they are generally available. I believe that Challenge '86 has been a good experience, especially as the young people involved were mostly associated with businesses which have to appreciate the abilities of young people in this country. Whether we are speaking about La Ronde or about non-profit organizations, many people have received help from this program. Generally speaking, I believe that people appreciate the Challenge '86 program.

Mr. Riis: Mr. Speaker, I listened with interest to the Minister's speech and found it to be most informative. We always appreciate his attempts to keep Members informed of statistics on a weekly and monthly basis with regard to how the Department is performing in lowering unemployment. I would like to ask for one small point of clarification. Having looked at the unemployment figures for the last few months it seems to me that the unemployment figures for the last reported period were up slightly over the previous period. I think it was 9.3 or 9.5 per cent. In his Throne Speech address the Prime Minister (Mr. Mulroney) said that unemployment is at its lowest level in five years. Is it correct that in a sense he was not quite accurate?

Mr. Bouchard: Mr. Speaker, I think that was a global evaluation. The trend for the unemployment rate is not regular. It may be down for July and up for August. I think that generally the trend was positive. The rate of unemployment in the country is generally the lowest for the last five years. My understanding is that the reference in the Prime Minister's (Mr. Mulroney) speech was in this sense.
