CONSTRUCTION OF PORT-CARTIER PRISON—REQUEST FOR EXPLANATION OF CHOICE OF CONSULTANT ENGINEERS

Mr. Don Boudria (Glengarry—Prescott—Russell): Mr. Speaker, my question is directed to the Prime Minister or, in his absence, to the Deputy Prime Minister and concerns the political patronage involved in awarding contracts for the prison at Port-Cartier.

Today it was reported in the press that one of the architects for the consortium that was awarded the contract said he was told to utilize the services of consulting engineers Desseau, Dupont and Desmeules from Montreal. Could the Prime Minister inform the House why his Government made the architects hire this firm? Could it be because the firm contributed several thousand dollars to the Conservative Party's coffers, or is it just a coincidence?
