# **BREAST IMPLANTS**

#### **EL SALVADOR**

While we all laud this country for reaching a peace settlement, the fact is that El Salvador is still not safe for all of its citizens.

British Columbians have rallied behind the Garcia family whose claim to remain here in Canada has been rejected. There is every reason to believe that the Garcias would be in danger if they are returned to El Salvador.

Mrs. Garcia was under suspicion just for being a trade unionist. While living in El Salvador, the family car was riddled with bullets, the family home was bombed and the Garcias were held hostage for 11 days.

Just last week, a trade unionist was assassinated in El Salvador. Incredibly, the Immigration Department feels that this is a safe environment.

I ask the Minister of Immigration to look realistically at the situation in El Salvador and to review the claim by the Garcias. This could be a matter of life and death.

## MUNICIPAL INFRASTRUCTURE
