

IMPROVEMENT AT STEAMSHIP EMPRESS DOCK

Council in Committee Re- commends New Ramp Be Constructed

PROSPECT POINT PARK IS URGED

Mayor Says Proper Firing Would Lessen Smoke Nuisance

The committee of the whole, in session this morning, decided to recommend to the Common Council that a new ramp be built in the steamer Empress dock, at Prospect Point. The committee also discussed a progress report of Commissioner Harding on the "smoke nuisance" and a request by J. Fraser Gregory that the street leading from Douglas avenue to their mill be taken over by the city and that the city lay out a park on the shore of the river at Prospect Point.

Commissioner Bullock presented a letter from J. M. Woodman, general superintendent of the New Brunswick Division of the C. P. R., offering to pay an increased rental of 12 per cent on 10 per cent of the cost of a new ramp at the steamer Empress dock, estimated at \$25,000, for the part of the year in which the dock was used by the steamer and named that the work be proceeded with and the expenditure charged to next year's expenditure. It was found necessary to have the work cleared and expressed the opinion that the rental should be on a yearly basis for the part of the year the dock was used by the steamer.

DEVELOPMENT SUGGESTED

J. Fraser Gregory was heard in connection with the taking over by the city of a street leading through the property of Murray and Gregory to their mill. He said that unfortunately he was rapidly approaching when they saw mill would cease to operate and they would be compelled to vacate the property. He had a residential district. The street had been laid out and would be decided to be a residential street. At present there was an 8 inch water main laid and sewerage could be installed. At the present time there were nine houses all occupied on the property.

He also suggested that the city acquire a strip of land along the river bank and develop it as a park which was the best place from which to view the river. The Commissioner Frink said this matter had been considered a number of times and his department had a good deal of correspondence in connection with it. He would gather this information all together and bring it to the council next Monday.

Power Co. To Take Over By Tonight

At noon today the New Brunswick Power took over a part of the load which has been carried for the last three months by the New Brunswick Power Commission and at midnight tonight will take over the rest. The current purchased by the company from the commission, under the contract made last fall between the company and the commission would have gone to waste over the dam this spring while the freshet was on. During the time the Power Co. plant was not generating power the machinery was given a thorough overhauling. About \$500,000 k. w. h. was taken by the Power Co. in the time they were linked up to the Musquash system.

NEW REGULATIONS FOR N. B. THEATRES

Amount of Fees to Be Collected in Towns and Villages After Today

The new order-in-council respecting revised theatrical and film regulations will become effective tomorrow. The order provides that every theatre owner, lessee or other occupant shall obtain a license. The fees to be charged will include:

- For each seat, 15 cents.
- For each row of film, not more than 1,100 feet submitted to the New Brunswick Board of Censors, an additional fee of \$1.50.
- For every additional hundred feet of film, 15 cents.
- For appeal from the decision of the board a fee of \$5 per reel shall be paid.
- For every cinematograph or moving picture machine used, for machine certificate, \$5.

THEATRE BOX LIST

Every owner, lessee or occupant of a theatre, and every owner, user, or exhibitor, of every cinematograph shall pay the following fees:

In all towns or cities with a population not exceeding 1,500, 5 cents per seat.

In all towns over 1,500 population and up to 2,000, 10 cents per seat.

In all towns over 2,000 population and up to 7,500, 15 cents per seat.

In all towns or cities where more than three performances are given in any week one-half the fee as set in section (a) to (d) inclusive shall apply.

Operators of cinematographs shall pay a license fee of \$2, and operators \$1.

The fees payable for amusement licenses are as follows:

For every assembly room, dance hall, billiard hall, concert hall, rink, athletic track, race track, boxing alley, shooting gallery, tent, enclosure used as a place of amusement respectively.

For every theatre or place of entertainment not exceeding 5,000 a fee of \$1 per year.

In a village or town with a population over 5,000 a fee of \$2 per year.

POLICE COURT HEARS TALE OF ARREST TROUBLE

Geo. Sproule Accused of Attacking Officer After Irvine Arrest

Joseph Irvine pleaded guilty in the Police Court this morning to being drunk on the north side of King Street on Saturday night and also to resisting the police. George Sproule, who was with Irvine at the time, was charged with assaulting the policeman and pleading not guilty.

POLICEMAN'S STORY

Policeman Covey testified to meeting Irvine, Sproule and another about 9.50 p.m. He said that Irvine was drunk and Sproule told him that he could do nothing with him. The policeman twice told Irvine to go home and when he later refused, he arrested him. Sproule told him of him and would not let go. Irvine and the officer then got into a tussle. Irvine hit the policeman and they fell with the two men on top of the officer. Policeman Garter then came to the assistance of the witness.

To Ralph G. McInerney, who appeared for Sproule, the witness said that he was down and both were on top of him before he used his baton. It was what Sproule said that caused the trouble as he had tried to haul the prisoner away from the officer.

SECOND POLICEMAN

Policeman Garter testified to seeing the crowd and going to the assistance of Policeman Covey. When he saw them, Covey was on his back with Irvine on his knees. Sproule was on top of him and he was holding the officer's feet trying to catch hold of them. When the witness reached the scene all were on their feet again with Covey having hold of Irvine and Sproule were walking along with the witness. Sproule to one side and he came back again and the four went down together. Garter then let go of Sproule and assisted Covey to put the handcuffs on Irvine.

SPOULE TESTIFIED

Sproule testified on his own behalf and said that he had said nothing to Irvine to incite him to resist arrest. Claude Phinney also was there. They were walking along with the officer when Irvine said, "Why put on him and then resisted. Covey used his baton and hit Irvine over the skull with it. The witness was afraid that Irvine would be injured so took the baton and threw it away. He said that Garter then came along and started "beating" up the witness.

In reply to Policeman Covey, the witness denied that he had tried to take Irvine away from him.

The case was then postponed until this afternoon in order that Claude Phinney might be called for the defence.

EVIDENCE AUTO TIRE CASE HEARD TODAY

Joseph Hatty Charged With Buying Goods Knowing Them Stolen

Joseph Hatty appeared before Magistrate Henderson in the Police Court this morning on a charge of receiving stolen property, knowing it to have been stolen. He was not asked to plead. He had told Hatty where they had got the wheels. Hatty, he said, drove the witness home and asked him to get him a carburetor. Horgan was the witness to get him a spare tire. Ronald Horgan also testified and corroborated the witness' story.

James McInerney of White street, said that the boys talked with him and he told Hatty where he could purchase two tires. He was in the car when Hatty got the tires but did not hear any of the conversation.

In reply to Hatty, the witness said Hatty had said that he would buy the tires provided they were not stolen. The witness knew that Hatty did not know the boys and did not know the tires were stolen. The witness did not know at the time either that they were stolen.

The case was then continued until Wednesday afternoon at 2.30 o'clock to permit Kenneth C. Irving, owner of the tires, to be present. Hatty was again permitted out on bail, Fred Isaac and Peter Saab being his bondsmen.


