Of *Thomas Pye* and others, of the District of *Gaspé*; praying that the Senate will order the purchase of copies of a book published by the said *Thomas Pye*, entitled "Canadian Scenery, District of *Gaspé*."

Of *James E. Hadly* and others, Merchants and Shipmasters of vessels lying in the Harbor of *Amherst, Magdalen Islands*; praying that means may be taken to remove the obstructions to the entrance of the said harbor.

Of the *Ontario Bank*; praying for an Act to continue their Charter and to grant power to their Directors to change the Head Office or chief place of business to such place in the Province of *Quebec* or *Ontario*, as they may determine, with the sanction of the majority of the shareholders.
