centralized decision making. The cornerstone of agricultural reform that deserves our support, therefore, has to be the growth of private farms and the emergence of private farmers. The \$2.5-million Agricultural Credit Unions Project we are launching today aims to enhance reform in the agricultural sector through the introduction of credit unions in rural regions of Russia. The project will set up 20 credit unions over the next five years. By helping to create an appropriate policy framework in this way, we will encourage the development of hundreds more credit unions in the coming years. We hope that the availability of credit will allow farmers to start their own enterprises. This financial freedom should be one of the pillars for the creation of private farms. The Société de développement international Desjardins [SDID], I believe, is the perfect Canadian partner to share the Canadian experience with its Russian counterparts. The history of Mouvement Desjardins demonstrates the significant role played so ably by credit unions in the development of the agriculture sector in Canada... [Also] since the late 1980s, the SDID has been active in promoting credit unions and savings co-operatives in many of the countries currently in transition in Central and Eastern Europe... Let me conclude with my congratulations and best wishes to the SDID in undertaking this very important project.
