in Saskatchewan. The government has not particulars indicating from whom it was purchased and in what quantities, but efforts are being made to secure the same.

3. No. See answer to No. 1. The price agreed upon was \$3.40 per barrel on the basis of the options supplied f.o.b. the mill, with a milling in transit rate supplied by the mill to

the ultimate point of destination.

4. The arrangements made to secure the wheat for milling purposes were made by the government before the prorogation of parliament last session, but the details were not completed until September. The deliveries were directed by the commission, which paid the accounts therefor.

ST. VALLIER, BELLECHASSE COUNTY, POSTMASTERSHIP

3. Mr. Bérubé was rejected by the department under section 24 of the Civil Service Act, as unsuitable.

4. Under the act it then became necessary for the commission to make another assignment to the vacancy, and accordingly a certificate for the assignment of the candidate next in order of merit, Mr. Leopold Boulanger, was issued on the 21st March, and the department has advised the commission that this gentleman reported for duty on March 31,

- 2, 3, 4 and 5. The material necessary for the writing of a general history of the war is being compiled by the historical section, general staff. The exact number of volumes to be published cannot, at the present time, be determined, nor is it possible to say when this history will be completed.
