After that meeting has taken place I may have some figures, in which case I would be very glad to supply them.

Mr. Gordon: I would be very glad to do that, Mr. Speaker.

Whenever a Canadian student goes to the United States in order to carry on his schooling, can the students' assistance scheme be used in that case, so that the Canadian student attending an institution in the United States can take advantage of the loans guaranteed by the federal government?
