TABLING OF MOTION TO REMOVE CUSTOMS DUTIES ON  
PETROLEUM PRODUCTS AND EXTEND TARIFF REDUCTIONS  
INTRODUCED IN BUDGET OF FEBRUARY 19, 1973

**Hon. John N. Turner (Minister of Finance):** Mr. Speaker, at the conclusion of the last session the House had not completed consideration of two sets of proposed tariff reductions. Pursuant to Standing Order 60(1), I wish to table a notice of a ways and means motion which combines a previous notice of October 23, 1973, removing duties on certain petroleum products and a notice of January 10, 1974, extending tariff reductions introduced in the budget of February 19, 1973. These proposals are reintroduced without change.

## GRAIN

PROVISION OF BOXCARS—REQUEST FOR UNANIMOUS  
CONSENT TO MOVE MOTION

**Mr. S. J. Korchinski (Mackenzie):** Mr. Speaker, as a result of grain exports lagging by 34 per cent, terminal elevators half full, elevator space at country elevators either non-existent or at a minimum because annexes cannot be filled with tough grain, railway companies 130 million bushels behind in grain shipments, and the minister and the Wheat Board making an appeal for grain even though agents cannot accept it, I move, seconded by the hon. member for Swift Current-Maple Creek (Mr. Hamilton), under the provisions of Standing Order 43:

That the whole question of grain movement be referred to the Standing Committee on Transport and Communications to make an emergency study with a view to recommending to the government and the Canadian Transport Commission that they order the railways to allocate sufficient cars to move grain in order that full advantage can be taken of the buoyant market.

## VETERANS LAND ACT

PHASING OUT ON MARCH 31, 1974—REQUEST FOR UNANIMOUS  
CONSENT TO MOVE MOTION

**Mr. Jack Marshall (Humber-St. George's-St. Barbe):** Mr. Speaker, I also wish to move a motion under Standing Order 43. The government's intention to phase out the Veterans Land Act on 31 March, 1974, denies to the veterans of Canada their rights under the veterans charter and breaks faith on a commitment made by government in the name of the people of Canada.

I therefore move, seconded by the hon. member for Peel-Dufferin-Simcoe (Mr. Madill):
