BUSINESS OF THE HOUSE

WEEKLY STATEMENT

Mr. Baker (Grenville-Carleton): I rise on a point of order, Mr. Speaker. I wonder whether the government House leader is in a position to announce the business for the balance of today, for tomorrow and for the first of next week.

Mr. Sharp: Perhaps I ought to begin by saying it is the intention of the government that the Easter adjournment shall begin at the end of the day on Wednesday, April 14, and that we shall return on April 26. I say this by way of a preliminary statement before filling in the business for most of the time between now and then. Today, I hope that after disposing of the motion I intend to move, and of which I have given notice, for an allocation of time in respect of Bill C-83—

Mr. Paproski: Shame!

Mr. Baker (Grenville-Carleton): Closure!

Mr. Sharp: —a motion which I hope we shall see agreed to more frequently by the opposition in the future in order to provide for the more orderly disposal of business, we shall then go on to consider the prisoners of war bill, C-92. Following that, in this order, for the remainder of today and tomorrow we shall take Bills C-92, S-32, C-88 and C-20. If the House agrees to the notice which is on notices of motions, we shall on Monday and Tuesday turn to the consideration of objections to the reports of the Redistribution Commissioners. After those have been disposed of, we shall return to the consideration, during the four days which will be provided in the allocation order, if it is accepted, of Bill C-83.

Mr. Hnatyshyn: Mr. Speaker, on the same point of order, may I ask the government House leader this question: In view of the resignation of the Minister of Consumer and Corporate Affairs, and in view of the fact that new laws to combat loan sharks and control business monopolies are now sitting in limbo, does the minister consider the situation is important enough to call for the announcement of
