#### **OIL COMPANIES' PRICING POLICIES**

Mr. Bill Domm (Peterborough): Mr. Speaker, the Thursday, April 5, edition of *The Globe and Mail* has revealed the court decision which found Imperial Oil Limited guilty of unfair dealings with independent retailers of gasoline in its efforts to keep the price of gasoline artificially high. It reported: "Judge James Trotter had reserved his decision following Imperial's recent one-week trial on a charge under the Combines Investigations Act of discriminating against the company because of its low pricing policies."

This is no different from the case in Peterborough, Ontario, where the Crown corporation, Petro-Canada, has literally forced an independent retailer to sell off eight service stations because of Petro-Canada's refusal to sell him petroleum products at the same discounted figure it sells to its companyoperated service stations in the same market area.

Petro-Canada was selling gas during the week of March 26 at 37.9 cents a litre, yet it was charging Mr. Grant Seabrooke, President of Seabrooke Motors Limited, 40 cents a litre wholesale. The result was to cut off supply by allowing its own company operations to sell for less than it was willing to sell to Mr. Seabrooke. Grant Seabrooke's retail outlets are now being sold because they can no longer compete against Canada's own state-owned oil company, Petro-Canada.

#### CONDEMNATION OF POLICIES AFFECTING WESTERN CANADA

**Mr. Arnold Malone (Crowfoot):** Mr. Speaker, the Liberal Government does not represent Canada. In 1968, when the present Prime Minister (Mr. Trudeau) first came to power, there were 27 Liberal MPs from the four western provinces; today there are two. In one year the Prime Minister spent 38 days in the eastern hemisphere. During the same time he spent five days in western Canada, three of which were to go skiing.

There are four major issues which highlight western concerns: energy, agriculture, transportation, and tourism. The Liberal attack on western transportation has yielded a system farmers cannot afford. Their attack on energy was to lay central claim to a provincial resource. Their removal of VIA Rail service from Winnipeg, Saskatoon, Edmonton, Jasper, and Vancouver has negatively impacted on our tourist industry.
