In the past five years Canada's over–all unemployment [Translation] rate has dropped from 12 per cent to about 7.4 per cent. This is solid evidence that real progress is being made toward the goal of strengthening our economy.

In spite of recent successes, however, more work has to be done. Canadians from sea to sea have pointed to the federal deficit as a major economic concern. The upcoming federal budget must reflect Canada's concern for the deficit. Responsible and reasonable expenditure restraint must continue. Taxation systems must be reasonable and fair. We must all work toward deficit reduction to ensure that the next generation of Canadians can work and live in a better Canada with a stronger economy.

GOODS AND SERVICES TAX

Mr. Rod Murphy (Churchill): Mr. Speaker, events of this week have proven once and for all something I have long suspected. The New Democrats are the only party opposing the GST. We are the only party that Canadians can depend upon to stand up and fight for what Canadians really want.

Eighty per cent of Canadians do not want a goods and services tax. At the same time, the Conservative government seems determined to ram this goods and services tax down the throats of Canadians and we learned this week that the Liberal Party is not going to do very much to stop it.

Why is this? Now we know. Mr. Chrétien, one of the leadership hopefuls, has said on national television this week he really does not know what he would do about the GST. We in the New Democratic Party are going to do everything in this House of Commons that we can legitimately do to fight the GST. We are going to do it in the regions, the communities and the constituencies of Canada and we welcome all the help we can get.

But why was he so badly advised? I for one believe the blame rests primarily with the unelected leaders of amateur sports who gave very misleading advice to the minister because this time around they were concerned they would lose control over amateur sports in Canada. They had to deal with a minister who was not afraid to voice his opinion, to work closely with the Canadian people and, on behalf of amateur sports and especially the athletes, to express challenging ideas likely to propel Canada on the international scene.

I would suggest that criticism be aimed, not at the minister for his technical mistake, but indeed at his advisers, those people who preside over amateur sports in Canada. We serve them notice that for once the government is monitoring their performance and will assume full responsibility for amateur sports with a view to providing proper guidance to our athletes and help them to achieve and to carry Canada's colours on the international scene.
