NOT NECESSARY TO DEMAND RECEIPTS AS TO REGISTRATION

Many Appear To Be Going Further Than Law.

NO PROSECUTIONS OCCUR

Toronto People Who Refused to Sign Cannot Leave City or Get Jobs.

(Special to The Advertiser.)

TORONTO, June 25.—There is the greatest divergence of opinion as to the proper course for merchants, hotelmen, ticket agents and others to adopt towards the public to ascertain whether or not each man has registered.

At the conference in the mayor's office today Mr. George Murray of the Canada Registration Board cleared up many popular misconceptions.

"It is not necessary, according to the law, that any hotel proprietor, railway company or merchant, or anyone doing business should demand the registration card of those they are doing business with," said Mr. Murray. "In a prosecution it would be necessary for the crown attorney to prove that the hotelman or the railway or steamboat agent had knowledge that the person he was dealing with had not a registration card."

Further Than Law.

Mr. Murray was asked how it was that various people were asking from their customers the production of registration cards before they would sell to them.

"There are two answers to that as far as I can see," said Mr. Murray. "First, that the people of Canada are going to see that the Government in this registration and so absolutely loyal that they are going farther than the law goes to see that persons with whom they are doing business are registered. Secondly, that it is true to reports by unauthorized persons given to the press that people would be required to do this. There are two ways that anyone

could have found out. One is by merely asking a lawyer, and the other by asking the registration board."

Mr. Murray made it plain, however, that any merchant or agent must have a guilty knowledge that a person he is dealing with has not registered before he can be successfully prosecuted.

Since yesterday he said, the names of twenty aliens in Toronto had been handed over to the police as a result of the registration.

At present, according to inquiries today, the men and women who failed to register are sharing practically all the privileges enjoyed by those who did, except that they cannot leave the city and that they are denied employment at the large business establishments.

GEORGE PLEADS FOR SETTLEMENT OF IRISH ISSUE

It Is Increasing Difficulties of British and U. S. Governments.

SHORTT REVEALS PLOTS

LONDON, June 25.—In the House of Commons today David Lloyd George urged the need of settling the Irish problem, because it was increasing the difficulties not merely of the Government, but the difficulties of the United States Government in conducting the war.

Former Premier Asquith again appealed to the Government to order the Irish question to the dominions conference.

The debate was opened by Sir Edward Carson, the Ulster leader, who, in accordance with a previous arrangement, raised the whole question of the Government's policy in Ireland, with special reference to the recent proclamation of the lord-lieutenant and the recruiting movement.

Should Go Whole Way.

Sir Edward said that if the premier believed he was justified, in order to carry on the war in trying to bribe Ireland into conscription, thereby incurring a grave political risk, breaking a party truce, and shattering the foundations of the Unionist party, he ought, in taking this desperate course, at least to have determined to go right through with it.

"The Roman Catholic hierarchy," he said, "has gone to lengths in opposing conscription which no civilized modern community ought to tolerate for a moment if you have to endure all this indignity and humiliation, you are crawling upon your knees to a particular church."

Lloyd George appealed to Sir Edward Carson to show the same spirit he displayed two years ago and subsequently, "in using his very great abilities and unrivalled influence in Ulster to try to secure some measure looking to the willing consent of the Irish people to Imperial unity."

The Government, he said, stood by the policy it had proclaimed on April 3, but in the method of administering it to the Government must be advised by the men it had intrusted with the administration of Ireland.

Shortt Tells of Plots.

Edward Shortt, chief secretary for Ireland, speaking in the House of Commons today on the Irish question, said he hoped to satisfy the House that the German plot in Ireland was a real and imminent danger to this country. He said he was satisfied that both the clergy and the Nationalists had used their influence respectively to assist in keeping the peace.

Secretary Shortt said the Government had found that Germany was in touch with Ireland, and that not only were messages going to Ireland from German sources, but that they were going from Irish sources to Germany.

Canvass Boat a Clue.

The collapsible boat in which the man, who is now a prisoner, landed in Ireland from a submarine, was made of canvas, similar to that made at Hanover before the war.

Mr. Shortt said the Government knew that in a certain part of Germany a large amount of ammunition was loaded on submarines; this was being sent to localities where it was being distributed to the Irish Nationalists.

Mr. Shortt said that since the premier had announced that the Government policy with regard to Ireland, circumstances had entirely changed, there being two main causes for the change.

The first and most far-reaching cause, he said, was the discovery of a German plot in Ireland which he hoped, he would be able to satisfy the House, was a real and imminent danger to this country. In addition, there was the fact that the feeling in Ireland against conscription and the Government was necessarily followed that feeling had been used by the extremists in a physical movement in conjunction with the German plot.

The speaker said he did not for a moment say that any substantial proportion of those in Ireland who were opposed to conscription had any knowledge that they were being used to further a German plot.
