

SAVAGE, Hon. THOMAS, J.P. (*Golfc.*)

Of English descent. B. in the Island of Jersey, 16 Sept. 1808. Ed. there. M. at Berthier (*en haut*), P.Q., April 1847, Mdle. Julie Laliberté. A merchant and ship-owner. Is a Major in the Militia. Unsuccessfully contested Gaspé for Can. Assem. g.e. 1863. Apptd. to L.C., 19 Nov. 1873. A Conservative.—*L'Anse au Cap*, Q.

STARNES, Lieut. Col. Hon. HENRY, J.P. (*DeSalaberry.*)

Grand-s. of a U.E. Loyalist, of English descent, who settled in Can. at the close of the American revolution. Father married a French Canadian lady. B. at Kingston, Ont. 13 Oct. 1816. Ed. at the Montreal Coll. and the Revd. Mr. Esson's Academy. Was for some years a mem. of the firm of Leslie, Starnes & Co., wholesale merchants, Montreal. Has been a dir. of *La Banque du Peuple*; a Warden of Trinity House; Vice-Presdt. of the Board of Trade; and for many years Manager in Montreal of the Ontario Bank. Chairman of the Can. Board of dir. of the Liverpool, and London and Globe Insu. Co. Was Mayor of Montreal in 1856 and 1866 and is Lieut. Col. 1st Montreal Centre Reserve Militia. Sat for Chateauguay in Can. Assem. from g.e. 1857 to g.e. 1863, when he retired. Unsuccessfully contested Montreal at g.e. 1857. Declined a seat in the Quebec Cabinet, 1867. Sworn of the Ex. Council 8 March 1878. Was Speaker of the L.C. Oct. 1879, and acting Commr. of Agriculture and Public Works during the absence on public business of Hon. H. G. Joly. Was Commr. of Railways, from 31 July 1882, to Jan. 1884, Apptd. to L.C. 1867. A Liberal Conservative.—104 St. Alexander Street, Montreal; St. James' Club.

WEBB, Hon. WILLIAM HOSTE, Q.C. (*Wellington.*)

Eld. s. of the late Commander Edward Webb, R.N., who came to Can. and settled at Hoste Farm, Brompton, Que., in the year 1836. B. in Hampshire, Eng., 24 Nov. 1824. Ed. at the Royal Naval Sch., near London. M. Isabella, dau. of the late Lieut. W. Morris, of the 97th Regt., and of Parkswood, near Lennoxville, Que. Called to the Bar, L.C., 1851. Appdt. a Q.C. in 1867. Has been Mayor of Melbourne. Was the first Warden of the Co. of Richmond, Que., and has, since its foundation, been a Trustee of St. Francis Coll., Richmond, Que. First returned for Richmond and Wolfe in Can. Assem. 1857 and sat until
