to state such Property to belong to the Person so named, and another, or others, as the Case may be; and whenever, in any Indictment or Information for any Felony or Misdemeanor, it shall be necessary to mention, for any Purpose whatsoever, any Partners, Joint Tenants, Parceners. or Tenants in Common, it shall be sufficient to describe them in the Manner aforesaid ; and this Provision shall be construed to extend to all Joint Stock Companies and Trustees.

'XV. And with respect to the Property of Property belong-'Counties ;' Be it enacted, That in any Indict- &c. may be laid ment or Information for any Felony or Misde- in the Inhabit-meanor committed in, upon or with respect to ty: any Bridge, Court House, Gaol, House of Correction, Infirmary, Asylum or other Building erected or maintained in Whole or in Part at the Expense of any County or City and County, or on or with respect to any Goods or Chattels whatsoever, provided for or at the Expense of any County or City and County, to be used for building, altering or repairing any Bridge, Court House or other such Building as aforesaid, or to be used in or with any such Bridge, Court House or other Building, it shall be sufficient to state any such Property, real or personal, to belong to the Inhabitants of such County or City and County ; and it shall not be necessary to specify the Names of any of such Inhabitants.
